# 1 Getting Started

---

---

## Welcome

This *Quick Reference* is designed to help you perform all programming required for proper operation of PARTNER Messaging once the messaging module has been initially installed. It includes programming tasks you must perform for the communications system, as well as for PARTNER Messaging. Procedures for routine tasks that a System Manager is required to perform in order to manage PARTNER Messaging are also included in this *Quick Reference*.

For instructions on how to install the PARTNER Messaging module in the communications system carrier, as well as for information regarding every feature the system offers, refer to the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*.

---

## System Services and Features

To automate the call handling, call answering, and voice messaging needs of your company, PARTNER Messaging offers three voice messaging services—Automated Attendant Service (AAS), Call Answer Service (CAS), and Voice Mail Service (VMS). The capabilities provided by these services are highlighted in the illustration on [page 11](#).

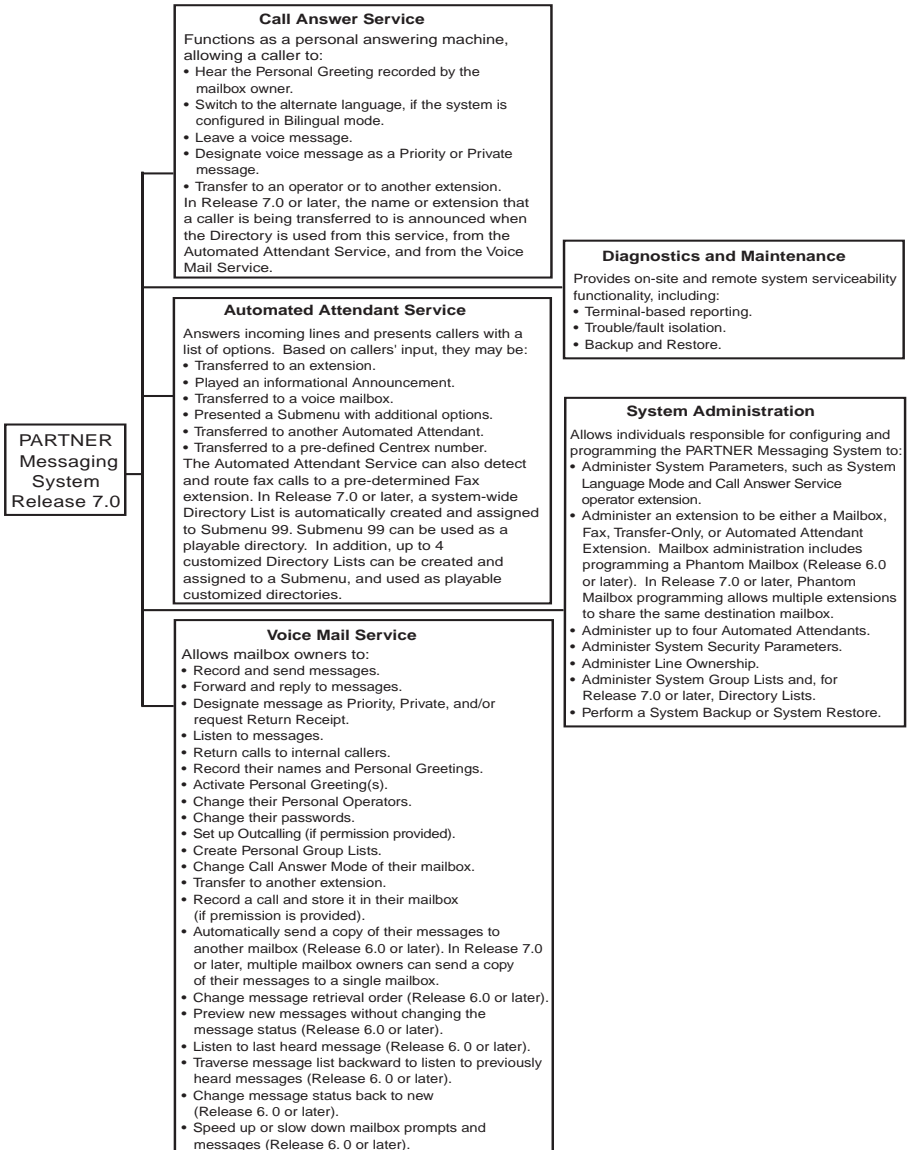
The system features include System Administration, Diagnostics and Maintenance, and Backup and Restore. The System Administration feature allows the System Manager to administer the system locally or remotely using a Touch-Tone telephone. This *Quick Reference* describes the Touch-Tone telephone method for System Administration.

System Administration can also be performed locally from a PC or laptop running the PARTNER Messaging System Administration software which provides a Graphical User Interface (GUI) for system programming. In Release 6.0 or later, the GUI System Administration software also provides the *Unified Messaging Application* that allows mailbox owners to access their voice messages as email from a PC. See *PARTNER Messaging 7.0 System Administration, Getting Started* for more information. In addition, *www.messenger* software is available for mailbox owners to view a list of their messages and select messages to be played via a Web browser on any PC. See the *www.messenger User Guide for PARTNER Messaging* for more information.

The Diagnostics and Maintenance features provide for on-site and remote system serviceability. The Backup and Restore features allow the System Manager to copy data and voice recordings onto external storage media and then copy this data back to PARTNER Messaging. Two Backup and Restore methods are available. Backup and Restore to the PARTNER Messaging Port Card provides a backup of a defined set of data and voice recordings. Backup and Restore using the PC-based PARTNER Messaging Release 1.0 or later System Administration software provides a backup of all system data and voice recordings, as well as the option to back up all voice messages in all mailboxes.

For more information about Diagnostics and Maintenance, and Backup and Restore to the Port Card, see the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*. For more information on Backup and Restore using the PC-based system administration software, see *PARTNER Messaging Release 7.0 System Administration, Getting Started*.

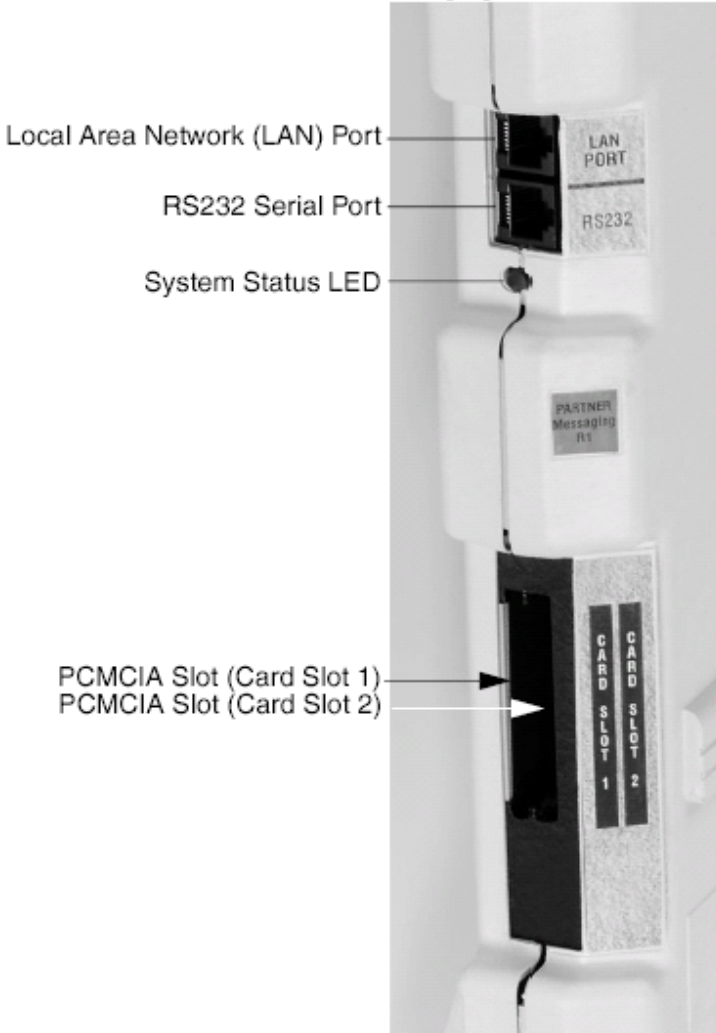

## The Module

PARTNER Messaging is a single module that resides in the communications system carrier.

## System Configurations

PARTNER Messaging is available in a 2-port, 4-port, or 6-port configuration with a message storage capacity of 100 hours, regardless of configuration. One module supports all three configurations. The Port Card installed determines the number of ports available.

### Port Assignments

The communications system assigns an extension to each port on the PARTNER Messaging module. The first extension assigned to the PARTNER Messaging module is assigned to Port 1, the second to Port 2, etc. The communications system assigns six extensions to the PARTNER Messaging module.

If an Outcalling action needs to be performed, the following ports are used:

- Port 2 if a 2-port card is installed
- Port 4 if a 4-port card is installed
- Ports 5 and 6 if a 6-port card is installed

The Remote Maintenance Device (RMD) is not assigned to an extension and can be accessed from any voice port.

## Programming Overview

This *Quick Reference* provides procedures for all programming required for proper operation of PARTNER Messaging.

- If you are performing initial programming for PARTNER Messaging, refer to [Chapter 2](#), [Chapter 3](#) and [Chapter 4](#) and perform the programming tasks in the order presented. Programming for both the communications system and PARTNER Messaging is required.
- If you are performing a routine task required to manage PARTNER Messaging—for example, reinitializing a mailbox password—refer to [Chapter 5](#).

### Communications System Programming

Communications system programming requires a system display phone at extension 10 (or 11), with a programming overlay placed over the phone's dialpad. Programming procedures are identified by # and a 3-digit code (for example, the procedure code for System Date is #101).

The procedures for programming the communications system appear in Chapters [2](#) and [4](#). For more information about communications system programming, see “Installation, Initial Configuration, and Programming” in the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*.

The communications system can also be programmed using PC administration software. For more information, see *PARTNER ACS Release 7.0, PC Administration, Getting Started*, document number 518-456-166.

### PARTNER Messaging Programming

PARTNER Messaging programming is performed locally or remotely using a Touch-Tone telephone. The procedures for programming PARTNER Messaging using a Touch-Tone telephone appear in [Chapter 3](#). System administration can also be performed locally from a PC or laptop running the PARTNER Messaging Release 1.0 or later System Administration software which provides a Graphical User Interface (GUI) for system programming. The PC or laptop must be connected to PARTNER Messaging via the LAN port through either a network or

direct connection. See *PARTNER Messaging Release 7.0 System Administration, Getting Started* for more information.

## Planning Forms

Before beginning initial PARTNER Messaging programming, you should have the following forms:

- A completed set of PARTNER Messaging Planning Forms. For a blank copy of the forms, refer to [Appendix B](#) in this guide or to the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*.
- An updated set of planning forms for your communications system. For a blank copy of the relevant forms for PARTNER Advanced Communications System (ACS) Release 4.0 or later, refer to [Appendix C](#) in this guide or to the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*. For all other PARTNER communications systems, refer to the *System Planner* for the communications system.

Be sure to update the appropriate planning forms when you make changes to the system after initial installation and setup, so there is a written record of your system's configuration. You can also print out a system configuration report using a PC connected to PARTNER Messaging. See the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide* for more information.



# 2 Initial Preparation

## Overview

This chapter provides initial communications system programming procedures that must be performed before the procedures in [Chapter 3, “Programming the Messaging System”](#) and [Chapter 4, “Programming the Communications System,”](#) The initial communications system programming procedures are:

- Assigning VMS Hunt Group Extensions
- Assigning Transfer Return Extensions
- Assigning Outgoing Call Restriction

You must perform the first two procedures for every installation. The procedure for [“Assigning Outgoing Call Restriction”](#) is strongly recommended to ensure system security.

Communications system programming requires a system display phone at extension 10 (or 11 if available), with a programming overlay placed over the phone's dialpad. Programming procedures are identified by # and a 3-digit code (for example, the procedure code for System Date is #101). For more information about communications system programming, see “Programming the Communications System” under “Installation, Initial Configuration, and Programming” in the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*.

This chapter also provides a description of how the communications system extension numbers are associated with the PARTNER Messaging module. You need to know this information in order to assign VMS Hunt Group Extensions. See [“Determining the Extensions Associated with the PARTNER Messaging Module” on page 25](#).

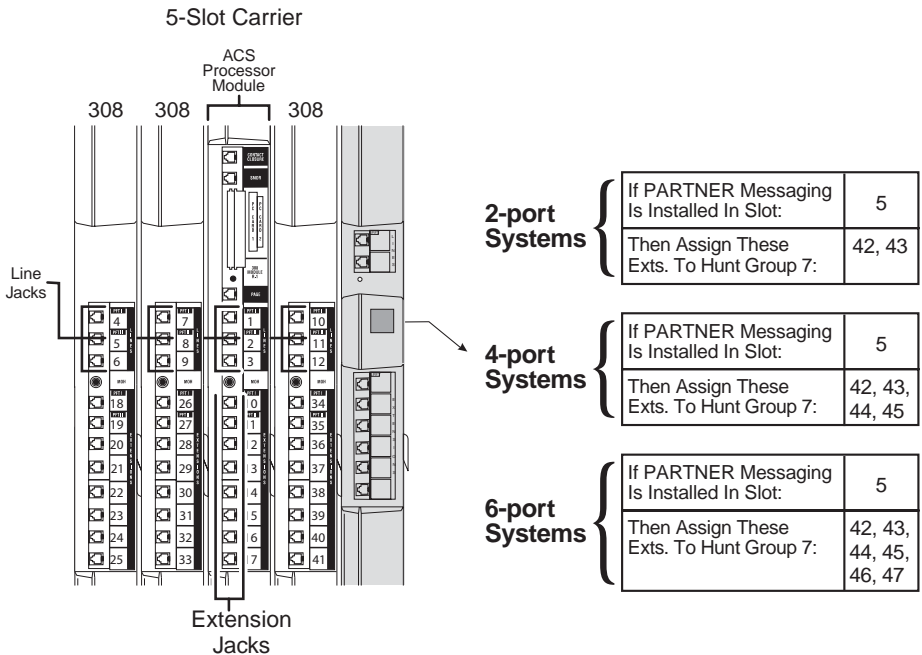
For additional information required to perform the procedures in this chapter, if your communications system is a PARTNER Advanced Communications System (ACS) Release 4.0 or later, refer to a completed copy of Forms F3 and F5 in the *System Planner*. A blank copy of these forms is provided for your reference in [Appendix C](#). For all other PARTNER communications systems, refer to the appropriate form in the *System Planner* for your communications system.



## Determining the Extensions Associated with the PARTNER Messaging Module

The communications system recognizes the PARTNER Messaging module as a 6-extension module, although the PARTNER Messaging module has no physical jacks. PARTNER Messaging ports are assigned to extensions on a communications system module beginning with the lowest extension number. For example, if the six extensions allotted on a communications system module were extensions 42 through 47, PARTNER Messaging Port 1 would be assigned to extension 42, Port 2 to extension 43, etc. (This is in contrast to PARTNER MAIL VS® Voice Messaging System where Port 1 would be assigned to the highest extension number, or extension 47 in the example provided here.)

### *Example of How the PARTNER Messaging Module Ports are Assigned to Extensions on a PARTNER Advanced Communications System R6.0 or Earlier*



## Assigning VMS Hunt Group Extensions

You must use this procedure to assign the extensions associated with the voice messaging system module to Hunt Group 7. This Hunt Group, which is called the VMS Hunt Group, is used exclusively for the voice messaging system.

For PARTNER ACS Release 4.0 or later, refer to Form F3 in the *System Planner*.

### Assigning VMS Hunt Group Extensions

7	Press <code>Next Data</code> until the display reads <code>1 Assigned</code> .
8	Repeat Steps 6 and 7 for each additional extension number that corresponds to the PARTNER Messaging ports.

<sup>1</sup> Some systems also allow programming from extension 11.

## Assigning Transfer Return Extensions

Use this procedure for extensions associated with the voice messaging system. If the voice messaging system transfers a call to an extension that does not answer and does not have coverage, the communications system transfers the call to the designated Transfer Return extension. The call rings at this extension until it is answered. Typically, the Transfer Return extension is the receptionist's extension, or extension 10.

### *Assigning Transfer Return Extensions*

Step	Programming Task
1	Press <b>#306</b> <sup>1</sup> .
2	At the Extension: prompt, enter the first PARTNER Messaging extension number specified.
3	At the Data: prompt, enter the extension number of the Transfer Return extension.
4	Press <b>(Next Item)</b> or <b>(Prev Item)</b> until the next PARTNER Messaging extension number displays.
5	At the Data: prompt, enter the extension number of the Transfer Return extension.
6	If additional PARTNER Messaging extensions are specified, repeat Steps 4 and 5 for each one.

<sup>1</sup> In some countries, the procedure code for Transfer Return Extension is #309.

## Assigning Outgoing Call Restriction

Use this procedure to restrict all extensions associated with the voice messaging system from making outside calls. Outgoing Call Restriction is strongly recommended, in particular, to protect system security when Outcalling privileges are assigned to users.

For PARTNER ACS Release 4.0 or later, refer to Form F5 in the System Planner.

**NOTE** ► *If Outcalling is permitted, be sure to create and assign Allowed and Disallowed Phone Numbers Lists to the Outcalling ports. (The Outcalling ports are Port 2 on a 2-port system, Port 4 on a 4-port system, and Ports 5 and 6 on a 6-port system.) See [“Programming Disallowed Phone Numbers”](#) and [“Programming Allowed Phone Numbers”](#) in [Chapter 4](#) for instructions.*

*If Centrex Transfer will be assigned for Automated Attendants, all PARTNER Messaging port extensions must have Allowed Phone Numbers Lists assigned to them that will permit the transfer to the Centrex Transfer destination phone number.*

*If [www.messenger](#) for PARTNER Messaging will be used, and the phone numbers designated by users during login will be external phone numbers, then all PARTNER Messaging port extensions must have Allowed Phone Numbers Lists assigned to them that will permit the voice messaging system to dial those external phone numbers.*

**Assigning Outgoing Call Restriction**

Step	Programming Task
1	Press <b>#401</b> .
2	At the <b>Extension:</b> prompt, enter the first PARTNER Messaging extension number specified.
3	Press <b>(Next Data)</b> until the display reads <b>2 Inside Only</b> .
4	Press <b>(Next Item)</b> or <b>(Prev Item)</b> until the next PARTNER Messaging extension number displays.
5	Press <b>(Next Data)</b> until the appropriate value displays.
6	Repeat Steps 4 and 5 for each PARTNER Messaging extension.
7	Press <b>(Feature) 00</b> to exit programming.



# 3 Programming the Messaging System

## Overview

This chapter describes the PARTNER Messaging programming tasks that must be performed after the module is initially installed.

**NOTE** ► *You can program PARTNER Messaging locally from a PC or laptop running the PARTNER Messaging System Administration software which provides a Graphical User Interface (GUI) for system programming. See PARTNER Messaging Release 7.0 System Administration, Getting Started for more information.*

## Global Commands

To save time when performing the programming tasks described in this chapter, you can enter an option before a menu or system response completes playing (excluding some error messages). You can also use the following shortcuts.

### Global Commands

* 7	From the System Administration (SA) Main Menu, go to the SA Activity Menu. From any SA Submenu, go to the SA Main Menu.

## Initially Logging in to System Administration

The first time you log in to PARTNER Messaging System Administration, you are prompted to set the password. Use the following procedure the first time you log in. Once you have set the System Administrator's Password, you can use the login procedure described in [“Logging in to System Administration” on page 130](#) in [Chapter 5, “Managing the System”](#).

**NOTE** ► *To log in to System Administration, you can press a voice messaging autodial button or press (Intercom) 7 7 7. For purposes of brevity, 7 7 7 is documented in the PARTNER Messaging procedures.*

## Selecting the System Administration Prompt Language

The System Administration Prompt Language is the language you hear when you program the system. You can administer the System Administration Prompt Language for any of the supported languages—U.S. English, Latin American Spanish, or Canadian French—regardless of the mode or the language(s) that are administered for the System Language or user mailboxes. See [“Programming the System Language Mode and System Language” on page 37](#) for more information.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 1–System Parameters* for the System Administration Prompt Language identified for your system.

**NOTE** ► *Select a language even if you want the System Administration Prompt Language to remain in U.S. English. This will ensure a change to the System Language Mode or System Language does not affect the System Administration Prompt Language.*

## Programming System Parameters

This section provides procedures for programming the System Parameters. Some System Parameters have factory settings that you do not need to program if they are appropriate for your system. In [Appendix B](#), refer to *PARTNER Messaging Planning Form 1 – System Parameters* for specific parameters for your system.

### Programming the System Language Mode and System Language

The System Language is the language callers hear. It can be set to one of three languages: U.S. English, Latin American Spanish, or Canadian French. The System Language Mode can be set to Monolingual or Bilingual. When the System Language Mode is set to Monolingual, callers hear system prompts in one of the three languages (the language that is programmed as the System Language). When the System Language Mode is set to Bilingual, callers hear system prompts in two of the three languages. The first language the caller hears is the Primary Language. The Secondary Language is the alternate language the caller can hear by pressing  $\star$  7. When a system is in Bilingual Mode, the users include instructions in their Personal Greeting for the caller to press  $\star$  7 to hear system prompts in the alternate language.

The same System Language Mode and System Language(s) apply to all Automated Attendants. The factory setting is Monolingual Mode, with U.S. English as the System Language. When the System Language Mode is set to Bilingual, the factory-set Primary Language is U.S. English and the factory-set Secondary Language is Latin American Spanish.

System Language is different from the System Administration Prompt Language. The System Administration Prompt Language is the language the System Manager hears when programming the system. In addition, System Language is different from the Mailbox Language that is programmed for each Mailbox extension. The Mailbox Language is the language the users hear after they call in to Voice Mail Service.

### **Setting the System Language Mode**

The factory-set System Language Mode for a new system is Monolingual. If you are programming a new system, follow this procedure if you want to change the mode to Bilingual.

### **Setting the System Language**

The factory-set System Language for a new system in Monolingual Mode is U.S. English. If you are programming a new system, follow this procedure if you want to change the System Language to Latin American Spanish or Canadian French.

If the Language Mode has been changed to Bilingual, the factory-set Primary Language is U.S. English and the factory-set Secondary Language is Latin American Spanish. Follow this procedure if you want to change the Primary and/or Secondary System Languages from their factory settings.

**NOTE** ► *If you have not set a System Administration Prompt Language or Mailbox Language, changing the System Language will affect the System Administration Prompt Language and the Mailbox Language.*

## Programming the Call Answer Service Operator Extension

The Call Answer Service Operator extension is the extension to which PARTNER Messaging transfers calls in the following situations.

- In Automated Attendant Service, when the Dial 0/Timeout Action is set to Call Answer Service Operator and the:
  - Caller presses 0 or presses \*8 then 0.
  - Caller makes no selection.
  - Caller presses 0 while using the Directory to transfer.
- In Voice Mail Service, when the:
  - User presses \*8 then 0.
  - User presses 0 while using the Directory to transfer.
- In Call Answer Service, when the:
  - Extension does not have a Personal Operator and caller presses 0 or presses \*8 then 0 while the greeting is playing.
  - Mailbox is in Answer-Only Mode, the extension does not have a Personal Operator, and the caller presses 0 or presses \*8 then 0 during the five-second timeout following the greeting.
  - Caller presses 0 or presses \*8 then 0 before or after leaving a message in a mailbox that does not have a Personal Operator.
  - Caller presses 0 while using the Directory to transfer.

The factory setting for the Call Answer Service Operator is extension 10. It is recommended that you do not change the factory setting.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 1 – System Parameters* for the Call Answer Service Operator extension.

**Programming the General Mailbox Owners**

PARTNER Messaging provides four General Mailboxes—one for each Automated Attendant. The General Mailbox extensions are 9991, 9992, 9993, and 9994. You cannot delete these extensions or change their phone status. Automated Attendant Service calls are directed to the Automated Attendant's General Mailbox when the Automated Attendant's Dial 0/Timeout Action is set to record a message in the General Mailbox and:

- Caller does not make a selection from an Automated Attendant Service Menu.
- Caller presses 0 while in Automated Attendant Service.
- Caller presses 0 while using the Directory to transfer.

The General Mailbox Owner is the extension whose Message Waiting Light is turned on whenever a message is placed in the General Mailbox. The factory setting for the General Mailbox Owner is extension 10. You can program a different General Mailbox Owner for each General Mailbox, or you can have the same owner for all the General Mailboxes.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 1 – System Parameters* for the General Mailbox Owners.

**Programming the Maximum Extension Length**

The Maximum Extension Length refers to the maximum number of digits (two, three, or four) callers dial, without having to enter #, to reach an extension, Calling Group, Hunt Group, mailbox, or Automated Attendant. The factory setting is two digits. PARTNER Messaging transfers calls when one of the following conditions occurs:

- Number of digits entered by the caller equals the Maximum Extension Length.
- Caller presses digits and #, indicating they have finished entering the extension.
- Five-second time-out period has expired.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 1 – System Parameters* for the Maximum Extension Length specified for your system.

## Programming Extensions

This section provides procedures to program an extension to be one of the following four types:

- Mailbox Extension
- Transfer-Only Extension
- Automated Attendant Extension
- Fax Extension

Every extension in PARTNER Messaging must be assigned a type in order to enforce Transfer Restrictions and designate transfer destinations, such as a Mailbox extension, an Automated Attendant extension, a Fax extension, or a Transfer-Only extension. When you program an extension, you also identify the phone status of that extension. If there is no telephone associated with the extension, PARTNER Messaging sends the call directly to Call Answer Service or Automated Attendant Service, depending upon the extension type. Transfer-Only and Fax extensions always have a telephone associated with the extension.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 2 – Extension Administration* for information required to program the extensions.

### Assigning Mailbox Extensions

You can assign up to 200 mailboxes. The factory-set Mailbox Size is 20 minutes and the factory-set Message Length is four minutes. When you assign an extension as a Mailbox extension, you are prompted to:

- **Identify whether a telephone is associated with the extension.** If a telephone is associated with a Mailbox extension, when a caller transfers from PARTNER Messaging to that extension, the call is sent to the extension's telephone. The Message Waiting Light on the telephone lights if a message is left in the Mailbox. If a telephone is not associated with the extension, the call is sent directly to the extension's mailbox. A Mailbox extension without a telephone is frequently referred to as a Guest Mailbox. A Guest Mailbox can be used by traveling sales people (who don't have telephones and who are frequently out of the office) to receive and retrieve messages. See [“About Guest Mailboxes” on page 47](#) for more information.

- **Administer a Directory Listing or Recorded Name.** Users and callers can use up to a 10-letter Directory Listing to address messages or transfer calls. The mailbox user's name can also be recorded. The System Manager and the mailbox user can record a name, but only the System Manager can administer a Directory Listing for an extension.
- **Administer the Message Length and Mailbox Size.** The Message Length is the maximum amount of time available for a caller to leave a message. It is also the maximum length of a message the user can create when sending, replying to, and forwarding a message. The Mailbox Size is the maximum amount of message storage time available in a mailbox.
- **Administer Outcalling.** Outcalling permission can be turned On or Off. The Outcalling feature dials up to five designated telephone numbers or pager/beeper numbers to notify a user that a new message has arrived in the user's voice mailbox. Users who use Outcalling are notified about new messages (all messages or only Priority messages) whether they are at their desks, on the road, or at alternate work locations.
- **Program the Mailbox Language.** The Mailbox Language is the language users hear after they log in to their mailbox. It is programmed for each Mailbox extension and can be administered for any of the supported languages, regardless of the Language Mode or language(s) that have been programmed for the system.
- **Administer Record-a-Call.** Record-a-Call is a feature that allows users at internal extensions to record their conversations in their mailbox while active on a call. This feature is available only if the communications system is PARTNER ACS Release 3.0 or later.
- **Administer Phantom Mailbox Property.** Available in Release 6.0 or later, the Phantom mailbox capability allows messages left for a mailbox extension to be deposited in a different mailbox. Messages are not left in the Phantom mailbox, but are left in the destination mailbox you specify. This feature can be used to assure messages are forwarded to an active mailbox when a mailbox becomes vacant. It can also be used to provide a common mailbox for two extensions, each with a different greeting. In Release 7.0 or later, multiple mailbox extensions can share the same destination mailbox, so that a single, common mailbox can be used for multiple extensions, all with different greetings.

**NOTE** 

*Confirm the Mailbox Size of the destination mailbox is sufficient enough to accommodate the additional messages that could be stored there.*

**About Guest Mailboxes**

Guest Mailboxes provide all the benefits of a regular mailbox (including Outcalling privileges) except the subscriber does not receive visual indication of a message deposited in the Mailbox since there is no telephone (and therefore no Message Waiting Light) associated with the mailbox. Subscribers can call the voice messaging system from any touch-tone telephone to receive their messages.

Review the following notes before you program Guest Mailboxes:

- If you *have* empty slots in the carrier, you can assign Guest Mailboxes to those extensions in the dial plan that correspond to the empty slot(s). When you assign guest mailboxes, it is recommended that you start assignments from the high end of the dial plan.
- After you create a Guest Mailbox, use [“Programming Automatic VMS Cover” on page 119](#) to assign automatic coverage to the Guest Mailbox. Calls to these extensions are routed immediately to the mailbox—the call does not try ringing the extension first.
- If you *do not have* empty slots in the carrier, you can assign Guest Mailboxes to the unused extension numbers associated with the voice messaging system module. You also need to assign automatic coverage to these Guest Mailboxes. You can use any of the six extensions on the voice messaging system module for Guest Mailbox assignments.
- Calls routed to these extensions are routed to the subscriber's mailbox depending on the extension used. Calls are routed on an immediate or delayed basis based on the following:
  - **For a 2-port system:**  
If the top two extensions are used, calls are routed to the subscriber's mailbox on an immediate basis.

If the remaining four extensions are used, calls are routed to the subscriber's mailbox after four rings (or after the number of rings program in the VMS Cover Ring Interval).

– **For a 4-port system:**

If the top four extensions are used, calls are routed to the subscriber's mailbox on an immediate basis.

If the remaining two extensions are used, calls are routed to the subscriber's mailbox after four rings (or after the number of rings program in the VMS Cover Ring Interval).

– **For a 6-port system:**

If all six extensions are used, calls are routed to the subscriber's mailbox on an immediate basis.

- A 2-port voice messaging system uses the top two extension numbers associated with the slot in which the module is installed. For example, if the module is installed in the last slot on a PARTNER ACS 5-slot configuration (see the figure on [page 25](#)), it uses extensions 42 and 43. In this case, you can use extensions 42 through 47 for Guest Mailboxes.
- A 4-port voice messaging system uses the top four extension numbers (for example, 42, 43, 44, and 45). In this case, you can use extensions 42 through 47 for Guest Mailboxes.
- A 6-port voice messaging system uses all six extension numbers (for example, 42 through 47). In this case, you can use extensions 42 through 47 for Guest Mailboxes.

## Assigning Transfer-Only Extensions

You can assign up to 400 Transfer-Only extensions. Transfer-Only extensions are extensions that do not require a mailbox. An example of an extension that could be assigned as a Transfer-Only extension is a conference room telephone. Transfer-Only extensions must be identified in PARTNER Messaging so that they can receive transferred calls (see [“Setting Transfer Restrictions” on page 92](#) for more information). You should assign PARTNER Calling Groups, PARTNER Hunt Groups, and the PARTNER ACS Release 3.0 and later Remote Maintenance Extension (76) as Transfer-Only extensions.

When you assign an extension as Transfer-Only, you are prompted to:

- **Administer a Directory Listing or Recorded Name.** Users and callers can use up to a 10-letter Directory Listing to transfer calls to the Transfer-Only extension. The Transfer-Only extension name can also be recorded.

**Assigning Automated Attendant Extensions**

You can assign up to 10 Automated Attendant extensions. An Automated Attendant extension is one that sends the caller to one of the four Automated Attendants.

When you assign an extension as an Automated Attendant extension, you are prompted to:

- **Identify whether a telephone is associated with the extension.** If a telephone is associated with the Automated Attendant extension, calls transferred to that extension from PARTNER Messaging ring at the telephone and, if unanswered, are handled by an Automated Attendant. If a telephone is not associated with the Automated Attendant extension, calls transferred by PARTNER Messaging do not ring at a telephone, but go directly to the Automated Attendant Service.

- **Administer a Directory Listing or Recorded Name.** Users and callers can use up to a 10-letter Directory Listing to transfer calls to the Automated Attendant extension. The Automated Attendant extension name can also be recorded.

## Assigning Fax Extensions

If an Automated Attendant has been assigned a Fax extension, when an incoming fax call is detected by the Automated Attendant, it routes the call to the Fax extension. When you assign an extension as a Fax extension, you are prompted to:

- **Administer a Directory Listing or Recorded Name.** Users and callers can use up to a 10-letter Directory Listing to transfer calls to the Fax extension. The Fax extension name can also be recorded.

## Programming the Automated Attendants

This section provides procedures to:

- Program Day and Night Main Menus.
- Create Submenus (for Release 7.0 or later this includes Submenus that play a Directory List)
- Create Announcements that may be used with the Main Menus or Submenus.
- Program the Schedule Options.
- Specify the lines assigned to each Automated Attendant.
- Identify a Fax extension to which each Automated Attendant transfers fax calls.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 3a – Automated Attendant Schedule and Fax Assignment*, *Form 3b – Day/Night Main Menu*, *Form 3c – Submenu*, *Form 3d – Recording Script*, and *Form 3e – Submenus with Directory List Assigned* for the information you need to program the Automated Attendants.

### Programming the Day or Night Main Menus

The Automated Attendant Service Day Main Menu is the top-level menu heard during the scheduled day hours when the business is open or during a temporary open schedule. From the Day Main Menu, callers can transfer to an extension, Centrex number, Hunt Group, Calling Group, or mailbox; hear a Submenu; or hear an Announcement. The Automated Attendant Service Night Main Menu is heard during the scheduled night hours when the business is closed or during a temporary closed schedule.

When you program a Day or Night Main Menu, you are prompted to:

- **Specify the Automated Attendant number.** The choices are [1– 4].
- **Select the Day Main Menu or the Night Main Menu.** Even if the Night Menu is identical to the Day Menu, you must program both if you plan to use both.
- **Listen to the menu prompt and menu definition.** Once you listen to the current definitions, you can decide which you want to modify.

- **Modify the menu definition.** This includes modifying the Selector Code Actions for the Selector Codes and the Dial 0/Timeout Action. Selector Codes are the choices on the menu. A Selector Code Action is what occurs when a choice is made from the menu.
  - Factory settings for the Selector Code Actions for Selector Codes [1–4] in the Day and Night Main Menus are set to Direct Extension Transfer.
  - For each Day Main Menu, the factory-set Dial 0/Timeout Action is Transfer to Call Answer Service Operator.
  - For each Night Main Menu, the factory-set Dial 0/Timeout Action is Record a Message in the General Mailbox.

**SECURITY ALERT:**

**For security purposes, delete all unused Selector Codes.**

- **Record a new menu prompt.** If you make any changes to Selector Codes or to the Dial 0/Timeout Action, you may want to record a new menu prompt. The factory-set Day Main Menu prompt is, *“Your call is being answered by PARTNER Messaging. Please enter the extension of the person you wish to reach. To transfer using the Directory, press star-two. For assistance, press zero or wait on the line.”* The factory-set Night Main Menu prompt is, *“Your call is being answered by PARTNER Messaging. Please enter the extension of the person you wish to reach. To transfer using the Directory, press star-two. Otherwise, please wait.”*
- **Save the menu definition.** You may use the existing menu prompt while saving any changes you have made to the menu definition.

### **Assigning Submenu 99**

In Release 7.0 or later, when you program a Day or Night Main Menu, you can assign Submenu 99 which is a playable Directory of all extensions in the system (Mailbox, guest Mailbox, general Mailbox, Transfer-Only, Automated Attendant, and Fax). PARTNER Messaging automatically creates and maintains a system-wide Directory List and assigns this list to Submenu 99. Extensions are automatically added and deleted from the list when you add or delete extensions from the system. When you assign Submenu 99 to a selector code for a Day or Night Main Menu or Submenu, the system-wide Directory List plays as the Submenu prompt. The name must be recorded for the name and extension to be heard when the Submenu prompt plays. If a name has not been recorded for an extension, after you or the Mailbox owner records a name, the name and extension is heard when the Submenu prompt plays. (Note, however, that when you *administer* the Directory List, you will hear all names and extensions that you have included in the list, even if a name has not been recorded for the extension.)

You cannot modify Submenu 99. The Selector Codes for Submenu 99 are automatically set to allow direct extension transfers for the extensions whose names are recorded in the Directory Submenu. It will always announce the system-wide Directory List as its greeting.

In addition to Submenu 99, you can create Submenus that play a customized Directory List. To do this, you must:

- 1 Create the customized Directory List. See [“Programming Directory Lists” on page 98](#).
- 2 Create a Submenu that plays the customized Directory List. See [“Creating Submenus to Play a Directory List” on page 78](#).

Like Submenu 99, all Directory Submenus (Submenus with a customized Directory List assigned) must be assigned to a selector code for a Day or Night Main Menu or Submenu so the Directory List plays as the Submenu prompt.

If you are using Submenu 99 or another Submenu that plays a customized Directory List, be sure to include a description of the directory for the selector code action in the recorded greeting for that Automated Attendant.

## Creating Submenus

An Automated Attendant Day or Night Main Menu is the first set of choices a caller hears. The Day or Night Main Menu provides nine options. If you need to provide more than nine, you must create a Submenu. From the Day or Night Main Menu, the caller can select the Submenu to hear additional choices.

There can be up to 99 Submenus shared among four Automated Attendants. A Submenu can be assigned to one or more Automated Attendants. Each Submenu can be up to two minutes long. The Submenu uses the same Dial 0/Timeout Action defined for the Day or Night Main Menu.

When you create a Submenu, you are prompted to:

- **Specify the Automated Attendant number.** Specify the Automated Attendant [1– 4] to which this Submenu belongs.
- **Specify a Submenu number and create the Submenu.** The choices are [1– 98]. In Release 7.0 or later, Submenu 99 is automatically created with the system-wide Directory List assigned. See [“Assigning Submenu 99” on page 67](#) for more information.
- **Create a Submenu to play a Directory List.** The choices are [1– 98]. In Release 7.0 or later, you can create a Submenu that plays a customized Directory List. See [“Programming Directory Lists” on page 98](#) and [“Creating Submenus to Play a Directory List” on page 78](#) for more information.
- **Listen to the Submenu prompt and menu definition.** The factory settings indicate the prompt has not been recorded and the Selector Codes for the Submenu definition are not used. This step is not required when creating a new Submenu; it is useful when modifying an existing Submenu.
- **Modify the Submenu.** This option allows you to modify the Selector Code Actions. Selector Codes are the choices on the Submenu. Selector Code Actions indicate what happens when choices are made from the Submenu. The factory-set Selector Code assignments are “...not used.”
- **Record new Submenu prompt.** You must record a Submenu prompt. The factory-set Submenu prompt is, “The Submenu prompt has not been recorded.”

## Creating Submenus to Play a Directory List

In Release 7.0 or later, you can create a Submenu that plays a customized Directory List. The Directory List must be created before you can perform this procedure. See “[Programming Directory Lists](#)” on page 98 for more information.

A Submenu that plays a Directory List, referred to as a Directory Submenu, plays the list as the Submenu prompt when the Submenu is assigned to a selector code for an Automated Attendant Day or Night Main Menu or another Submenu.

If a name has not been recorded for an extension included in the Directory List, the name and extension is not heard when the Submenu prompt plays. After you or the Mailbox owner records a name, the name and extension is heard when the Submenu prompt plays. (Note, however, that when you *administer* the Directory List, you will hear all names and extensions that you have included in the list, even if a name has not been recorded for the extension.)

You do not need to program the selector code options for a Directory Submenu. PARTNER Messaging automatically sets the selector codes to permit direct extension transfer for the extensions whose names are recorded in the Directory Submenu.

## Creating Announcements

An Automated Attendant Announcement is the information you record for a caller to hear. Once you create the Announcement, you can associate it with an Automated Attendant Main Menu or Submenu.

- Up to 99 Announcements can be recorded.
- Announcements can be up to four minutes in length (prior to Release 7.0, up to two minutes in length).
- The same Announcement can be used for more than one Main Menu or Submenu, and with more than one Automated Attendant.
- The factory-setting is “Announcement [nn] does not exist.”

## Programming the Schedule Options

The Schedule Options control the Day and Night Service operation of the Automated Attendants. The Schedule Options are:

- **Administer the Schedule Controller** – Determines which schedule the Automated Attendants follow—the Switch Mode, the Weekly Business Schedule, or a combination of both. The factory setting is to follow the Switch Mode.
- **Administer the Weekly Business Schedule** – If the Schedule Controller is set to follow the Weekly Business Schedule, or to follow both the Switch Mode and the Weekly Business Schedule, a Weekly Business Schedule must be programmed. The factory setting is “closed all days.”
- **Administer the Temporary Schedule** – Allows the Automated Attendants to operate in temporary closure or temporary open mode. The Temporary Schedule overrides both the Switch Mode and the Weekly Business Schedule. For each day with a temporary opening or temporary closing schedule, you specify the start and end time of the special schedule. During other periods of that day, the Automated Attendant operates in the appropriate mode based on its Schedule Controller setting. The Temporary Schedule can be programmed for the current day and/or the following six days. It also can be cancelled anytime before or while the Temporary Schedule is in effect. The Temporary Schedule does not carry over from week to week; it expires at the end of the day for which you created it.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 3a – Automated Attendant Schedule and Fax Assignment* for the information you need to program the Schedule Options.

### ***Administering the Schedule Controller***

The Schedule Controller determines which schedule the Automated Attendant follows—the Switch Mode, the Weekly Business Schedule, or a combination of both. If the Schedule Controller is set to follow both, when the Night Service button is pressed, the Automated Attendant operation changes to Night Service operation. When the Night Service button is pressed again, the Automated Attendant operation changes back to Day Service operation. These actions will override the business schedule until the next time that the business schedule indicates a transition should occur.

For example, assume the business schedule calls for the open period to be 9:00 AM to 5:00 PM. If the Night Service button is pressed at 4:55 PM, forcing a switch to Night Service operation and then the button is pressed again at 5:05 PM, forcing a switch back to Day Service operation, the Automated Attendant will not switch to the Night Service operation based on the Weekly Business Schedule until 5:00 PM the following day.

## Programming Line Assignments

**NOTE** ► Skip this procedure if your system uses only Automated Attendant 1.

For each line that is to receive Automated Attendant Service, you must assign an Automated Attendant number. There are no factory-set Line Assignments. If a call comes in on a line not assigned to an Automated Attendant, Automated Attendant 1 handles the call. A maximum of 41 lines (the communications system maximum) can be assigned among the four Automated Attendants. Line numbers should be entered as 2-digit numbers. For example, to designate line 1, enter 01.

## Assigning a Fax Extension to an Automated Attendant

When an Automated Attendant detects a fax call, it transfers the call to a specific extension or Hunt Group. The extension must first be programmed as a Fax extension type in order to identify it as a Fax extension for an Automated Attendant (see [“Assigning Fax Extensions” on page 62](#)).

PARTNER Messaging allows a maximum of one Fax extension per Automated Attendant. Multiple Automated Attendants can share the same Fax extension.

**NOTE** ► *Do not assign a Fax extension to an Automated Attendant if you are using the PARTNER ACS Release 3.0 or later Fax CNG Detection feature.*

## Setting System Security Parameters

System Security Parameters include Transfer Restrictions and Minimum Password Length. These features enhance the security of your system by reducing the risk of abuse by unauthorized users and by helping to prevent toll fraud.

The factory setting for Transfer Restrictions is On. When Transfer Restrictions are set to On, transfers (ⓧⓈ transfers, Automated Attendant Direct Extension Transfers, and Personal Operator transfers) are restricted to extensions that are included in the PARTNER Messaging extension list. The extension list includes extensions assigned as Mailbox extensions, Automated Attendant extensions, Transfer-Only extensions, Fax extensions, and the Call Answer Service Operator extension. This helps to prevent users and callers from committing toll fraud by transferring to an outside operator who could place a call for them. Transfer

Restrictions can be set to Off; however, changing the factory setting to this option is strongly discouraged, as it leaves your system vulnerable to toll fraud.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 5 – Security Settings* for the Transfer Restrictions setting for your system.



#### **SECURITY ALERT:**

**Setting the Transfer Restrictions to Off leaves your system vulnerable to toll fraud. We strongly recommend that you keep the Transfer Restrictions set to On.**

**Setting Minimum Password Length**

The minimum number of digits in user and System Administrator Passwords can be set to any number between 0 and 15; however, a password length of less than six digits is highly discouraged. Setting the Minimum Password Length to 0 digits means that no password checking will be done for users who do not program a password for their mailbox. The factory setting for the Minimum Password Length is six digits.

In [Appendix B](#), refer to *PARTNER Messaging Planning Form 5 – Security Settings* for the Minimum Password Length specified for your system.


**SECURITY ALERT:**

**A Minimum Password Length of at least six digits is strongly recommended. The shorter the Minimum Password Length, the more vulnerable your system is to abuse by unauthorized persons. Choose the largest acceptable minimum length in order to maximize the security of your system.**

## Assigning Line Ownership

If you have used VMS Line Coverage (#206, Option 3) on the communications system to assign coverage for a line, you must assign PARTNER Messaging Line Ownership to indicate which PARTNER Messaging mailbox or Automated Attendant extension should handle the call.

**NOTE** ► *On the PARTNER communications system, be sure you have programmed VMS Line Coverage (#206, Option 3).*

**Programming Directory Lists**

Available in Release 7.0 or later, you can program up to four customized Directory Lists that you assign to a Submenu for use in programming a Day and Night Main Menu. Once assigned to a Submenu, the Directory List (referred to as a Directory Submenu) becomes a playable directory providing the name and associated extension number of every member in the list. The name must be recorded for the name and extension to be heard when the Directory Submenu plays. (Note, however, that when you *administer* the Directory List, you will hear all names and extensions that you have included in the list, even if a name has not been recorded for the extension.) Once you or the Mailbox owner records a name, the name and extension is heard when the Submenu prompt plays.

When extensions are deleted from the system through extension administration, each Directory List is automatically updated. New extensions must be added to applicable Directory Lists.

In addition to the four Directory Lists, PARTNER Messaging automatically creates and maintains a system-wide Directory List (which is automatically assigned to Submenu 99). When you program a new Directory List you can either add individual extensions to the new Directory List, one at a time, or copy the system-wide Directory list to the new Directory List and then delete unwanted extensions.

## Backing Up the System to the Port Card

Following PARTNER Messaging programming, you can back up programmed configuration data and a subset of the Automated Attendant Main Menu prompts and Submenu prompts onto the Port Card. The backed up information may be used to perform a System Restore if the system fails and must be replaced or if data becomes corrupted. Refer to *“Backing Up the System to the Port Card” in the PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide* to see what information is backed up to the Port Card.

If you need your entire system backed up and restored, use the PC-based system administration software. See *PARTNER Messaging Release 7.0 System Administration, Getting Started* for more information.

**NOTE** ► *PARTNER Messaging must be in an idle state in order for the backup to begin. Prior to starting the backup process, the system will busy-out the messaging ports. During the backup process, the system will not answer calls. Backing up to the Port Card can take up to 20 minutes. Wait for a confirmation message or error message before hanging up.*

## Restoring the System



### CAUTION:

Restore should only be used to restore information to a new system when the old system fails. If a Restore is necessary, call the helpline or your authorized dealer.

When a system restore is performed, PARTNER Messaging reads data that was previously stored on the Port Card during a successful backup and writes it to the PARTNER Messaging system's memory. For more information about a system restore, see "Backing Up and Restoring the System" in the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*.



# 4 Programming the Communications System

---

---

## Overview

This chapter describes the communications system programming tasks that, depending on the features you require, must be performed after the PARTNER Messaging module has been initially installed and programmed. Before you begin the tasks in this chapter, be sure you have completed the tasks in [Chapter 2, “Initial Preparation,”](#) and [Chapter 3, “Programming the Messaging System.”](#)

Communications system programming requires a system display phone at extension 10 (or 11 if available), with a programming overlay placed over the phone's dialpad. Programming procedures are identified by # and a 3-digit code. (For example, the procedure code for System Date is #101.) For more information about communications system programming, see “Programming the Communications System” under “Installation, Initial Configuration, and Programming” in the *PARTNER Messaging Installation, Programming, and Troubleshooting Online Guide*.

Throughout this section, references to specific forms in the *PARTNER ACS Release 4.0 System Planner* are provided. For all other PARTNER communications systems, refer to the appropriate forms in the *System Planner* for the communications system.

## Automated Attendant Service

Before you begin, determine if Automated Attendant Service is indicated. For PARTNER ACS Release 4.0 or later, refer to Form B in the *System Planner*. Locate the Answering Option column and see if VMS-AA is entered for any lines.

If Automated Attendant Service is indicated, use the procedures in this section to assign Automated Attendant Service for each line requiring it; otherwise, skip to [“Call Answer Service” on page 116](#).

If you are assigning Automated Attendant Service, you will need information from a completed copy of Forms B, C, and F5.

### **Assigning Group Call Distribution (#206 Option 1)**

Use this procedure to specify the outside lines for which Automated Attendant Service is required and assign these lines to Hunt Group 7. For PARTNER ACS Release 4.0 or later, refer to Form B, Answering Option column, for VMS-AA lines.

**NOTE** ► *If the PARTNER Messaging extensions were restricted to Inside Only using Outgoing Call Restriction (#401), Outcalling will not work unless an Allowed Phone Numbers List is created and assigned. Outcalls can be made only to the numbers included in the list.*

### ***Programming a Do Not Disturb Button (F01)***

Used in conjunction with either Automatic VMS Cover or manual VMS Cover, this button lets a user send callers immediately to his or her mailbox (instead of ringing the extension first).

The Do Not Disturb button can be used to prevent calls for the extensions from audibly alerting (lights still flash). Users (with PARTNER II Communications System Release 4.0 or any PARTNER ACS release) who have VMS Extension Coverage—either automatic or manual—can use this communications system feature when they want calls sent to their mailboxes immediately.

The Do Not Disturb feature applies to internal calls, transferred calls, and incoming calls on lines for which Line Coverage Extension is assigned to the extension. This feature does not apply to calls assigned VMS Coverage (#206 Option 3); these calls ring four times before being sent to PARTNER Messaging for coverage.

### ***Programming a Station Lock Button (F21)***

The Station Lock feature is available to users with a system or standard Touch-Tone telephone. The Station Lock button can be programmed on a system telephone, through Centralized Telephone Programming. Users with standard Touch-Tone telephones can invoke this feature using Feature Code #21.

This button allows users to lock their telephones when they leave their desks for an extended period of time. To lock the telephone, the user presses the programmed Station Lock button and enters a four-digit code. To unlock the telephone, the user presses the button, then re-enters the code. It is recommended that the button programmed for this purpose have lights. The Station Lock feature should be used for all phones that have a Call Screening button.

The Record-a-Call button allows the user to begin recording a call in progress with one touch of a button. (If the system detects 15 seconds of silence after recording has begun, the system automatically turns off the Record-a-Call feature, and the user must press the programmed feature button to resume recording the conversation. The new recording will be saved as a separate message.) The recorded conversation is saved in the user's mailbox. The button programmed for this purpose must have lights.

## Overview


This chapter describes procedures for routine tasks that you may need to perform in order to manage PARTNER Messaging. Use these procedures to modify system programming after PARTNER Messaging has been installed and initially administered.

## Logging in to System Administration

## Changing System Administration Password

It is recommended that you change the System Administration Password after the initial administration of PARTNER Messaging has been completed, or after a service technician has accessed your system and you have provided the technician with the password. The System Administration Password can also be changed through the terminal interface.



### SECURITY ALERT:

**Changing the System Administration Password after initial programming is complete is strongly recommended to protect the security of the system.**

Users and callers can use up to a 10-letter Directory Listing to address or transfer calls. The System Manager has the capability to record a name and program the Directory Listing for any extension. However, if the System Manager does not record a name for Mailbox extensions, mailbox users are forced to record a name the first time they log in to their mailbox. Mailbox users do not have the capability to program the Directory Listing for their extension.

If the system is in Bilingual Mode, the Temporary Closure Greeting must include recordings in both languages.

The Temporary Schedule can be programmed for the current day and/or the following six days. It also can be canceled anytime before or while the Temporary Schedule is in effect. The Temporary Schedule does not carry over from week to week; it expires at the end of the day for which you created it.

# 6 Troubleshooting

---

---

## Overview

This chapter provides procedures for solving the most common problems that you may encounter with the system. You may be able to resolve a problem quickly and easily by following the appropriate steps. If you are unable to resolve a problem, call the helpline at 1 800 628-2888 or your authorized dealer.

---

## Problems and Corrective Actions

---

**PROBLEM:** System terminates recording of a name, greeting, message, or an Automated Attendant Main Menu, Submenu or Announcement before the user finishes.

---

### Possible Cause

### Corrective Action

Recording may have reached the time limit set for it.

Be sure the recording does not exceed the time limit, then re-record it.

Speaker's voice sounded like a Touch-Tone digit.

Re-record the message.

---

**PROBLEM:** Caller hears a busy signal when calling into Voice Mail Service.

---

### Possible Cause

### Corrective Action

All ports are in use or maintenance is being performed on the PARTNER Messaging module.

Try again later. If the condition persists, call the helpline at 1 800 628-2888 or your authorized dealer.

There are no ports assigned to Hunt Group 7.

Assign the ports to Hunt Group 7 (programming procedure #505).

---

**PROBLEM:** The first part of a Menu, Submenu, Announcement, or Personal Greeting is cut off.

---

### Possible Cause

### Corrective Action

You may have begun recording too early.

Re-record, speaking after the beep ends.

---

**PROBLEM:** Messages cannot be left in a user's voice mailbox.

Possible Cause	Corrective Action
Voice mailbox is full or system is full.	Delete messages that are no longer needed from the mailbox.
Mailbox is set for Answer-Only Mode.	Set mailbox for Record Mode.

**NOTE** 

*Mailbox Sizes range from 5 to 180 minutes or 120 messages. The message capacity of PARTNER Messaging is 100 hours. If a user frequently hears "Mailbox 80% Full" or "Mailbox Full," the System Manager may want to increase the storage size of the user's voice mailbox.*

---

**PROBLEM:** Calls are not being transferred properly.

Possible Cause	Corrective Action
Automated Attendant Service may not be administered properly.	Make sure the menu prompt matches the programmed Selector Codes.  If the problem involves the Call Answer Service Operator, be sure the proper extension has been designated as the Call Answer Service Operator.
The Phone Status for the extension is set to No. (i.e., the extension does not have a phone.)	Change the Phone Status to Yes (i.e., the extension has a phone).

---

**PROBLEM:** Message Waiting Light is not turning on and off.

<b>Possible Cause</b>	<b>Corrective Action</b>
The Phone Status for the extension is set to No (i.e., the extension does not have a phone). This is a normal operation.	If Message Waiting Light activation is desired, change the Phone Status for this extension to Yes (i.e., the extension has a phone).
The Message Waiting Light on the phone is broken.	From a system phone, check the Message Waiting Light: <ul style="list-style-type: none"> <li>• Go off-hook on the extension.</li> <li>• Enter <b>Feature</b> <b>0</b> <b>9</b> followed by the extension number to turn the light on.</li> <li>• Enter <b>Feature</b> <b>1</b> <b>0</b> followed by the extension number to turn the light off.</li> <li>• If the light is defective, replace the telephone.</li> </ul>
The extension has a mailbox and is also a General Mailbox Owner for one or more General Mailboxes. The Message Waiting Light will remain on if there are only new messages in either the extension's mailbox or in any of the General Mailboxes for which the extension is the owner.	Check the extension's mailbox and any General Mailboxes owned by the extension for new messages.

---

**PROBLEM:** A user is unable to log in to Voice Mail Service.

<b>Possible Cause</b>	<b>Corrective Action</b>
Password may be incorrect.	Check to see that the password is correct. If the user has forgotten the password, log in to PARTNER Messaging as the System Manager and reinitialize the Mailbox Password.
Someone else is already logged in to that mailbox.	Only one person can log in to a mailbox at a time. Change the Mailbox Password to prevent unauthorized use.

---

**PROBLEM:** Message Waiting Lights are not being turned on/off in a timely manner.

<b>Possible Cause</b>	<b>Corrective Action</b>
If only one Message Waiting Light is affected, the LED on the telephone set may be defective.	<p data-bbox="675 818 1053 877">From a system phone, check the Message Waiting Light:</p> <ul data-bbox="675 901 1053 1294" style="list-style-type: none"> <li data-bbox="675 901 1053 928">• Go off-hook on the extension.</li> <li data-bbox="675 952 1053 1075">• Enter <i>Feature</i> <b>0</b> <b>9</b> followed by the extension number to turn the Message Waiting Light on.</li> <li data-bbox="675 1099 1053 1222">• Enter <i>Feature</i> <b>1</b> <b>0</b> followed by the extension number to turn the Message Waiting Light off.</li> <li data-bbox="675 1246 1053 1294">• If the light is defective, replace the telephone.</li> </ul>

Possible Cause	Corrective Action
There is heavy call traffic and/or Outcalling usage on PARTNER Messaging. The Outcalling port(s) is also used in Call Handling. If your system performs heavy Outcalling or has heavy call volume, the port(s) may frequently be unavailable for Message Waiting Light activation/deactivation.	You may need to add more ports or reduce the frequency of Outcalling.
Message Waiting Light remains lit if there are any new messages in the mailbox.	Once the user listens to all new messages, the Message Waiting Light goes off.
Message Waiting Light may be indicating that there is a message in the General Mailbox.	If the user is the General Mailbox Owner, check the General Mailbox and listen to all new messages.

**PROBLEM:** Calls are not being answered by the correct Automated Attendant.

Possible Cause	Corrective Action
The line may be assigned to the wrong Automated Attendant.	Check PARTNER Messaging Line Assignments. Make necessary corrections.

---

**PROBLEM:** Outcalling is delayed.

---

**Possible Cause**

There is heavy call traffic and/or Outcalling volume on PARTNER Messaging. The Outcalling port(s) is also used in Call Handling. If your system performs heavy Outcalling or has heavy call volume, the port(s) may frequently be unavailable for Outcalling.

---

**Corrective Action**

You may need to add more ports or reduce the frequency of Outcalling or Record-a-Call privileges.

---

A line may not be available to place a call.

If all lines are in use when the system attempts to Outcall, the Outcall does not go through. The system counts the attempt toward the total number of attempts to be made during the specified time interval.

If the user's Outcalling Schedule end time is reached before the remaining attempts, these attempts will not be made by the system. You may need to obtain more lines if the problem occurs frequently.

---

**PROBLEM:** Outcalling to a pager is not working.

---

**Possible Cause**

---

**Corrective Action**

---

The Outcalling number is not properly programmed.

---

Check that the Outcalling number is correct. If not, reprogram the number.

---

Restrictions are still assigned to the Outcalling port(s). Outcalling ports are Port 2, if a 2-port card is installed; Port 4, if a 4-port card is installed; and Ports 5 and 6, if a 6-port card is installed.

---

Check the communications system programming to ensure that Outgoing Call Restriction (#401), Allowed Phone Numbers and Lists (#407/#408), and Disallowed Phone Numbers and Lists (#404/#405) have been programmed correctly for the Outcalling port(s).

---

Insufficient number of pauses in Outcalling number.

---

It is a good idea to include a pause between the line access number and the telephone number. It is also important to include a sufficient number of pauses between the pager number and the Personal Identification Number (PIN), or between the pager number and the Callback Number. Leave at least seven pauses after the pager number. You must allow enough time for the paging service to answer before the PIN and/or Callback Number is dialed.



<b>Possible Cause</b>	<b>Corrective Action</b>
There may not be a line available to place a call.	If all lines are in use when the system attempts to Outcall, the Outcall does not go through. The system counts the attempt toward the total number of attempts to be made during the specified time interval. If the user's Outcalling Schedule end time is reached before the remaining attempts, these attempts will not be made by the system. You may need to obtain more lines if the problem occurs frequently.
The message was received outside the hours programmed in the user's Outcalling Schedule or the Outcalling period is over.	This is normal operation. Outcalling is performed only during the hours specified by the user's Outcalling Schedule. Outcalling will be done only for messages received during the Outcalling period.
Outcalling may not be turned On.	Have the mailbox owner verify that Outcalling is turned On. The System Manager should also verify that the Outcalling privilege is assigned.
The number may be on the Disallowed Phone Numbers List.	Check Outgoing Call Restrictions, Allowed and Disallowed Phone Numbers Lists, and list assignments.

---

**PROBLEM:** Outcalling to a telephone is not working.

<b>Possible Cause</b>	<b>Corrective Action</b>
The Outcalling number is not properly programmed.	Check that the Outcalling number is correct. If necessary, reprogram the number.
Restrictions are still assigned to the Outcalling port(s). Outcalling ports are Port 2, if a 2-port card is installed; Port 4, if a 4-port card is installed; and Ports 5 and 6, if a 6-port card is installed.	Check the communications system programming to ensure that Outgoing Call Restriction (#401), Allowed Phone Numbers and Lists (#407/#408), and Disallowed Phone Numbers and Lists (#404/#405) have been programmed correctly for the Outcalling port(s).
A line may not be available to place a call.	If all lines are in use when the system attempts to Outcall, the Outcall does not go through. The system counts the attempt toward the total number of attempts to be made during the specified time interval. If the user's Outcalling Schedule end time is reached before the remaining attempts, these attempts will not be made by the system. You may need to obtain more lines if the problem occurs frequently.
The message was received outside the hours programmed in the user's Outcalling Schedule or the Outcalling period was ended.	This is normal operation. Outcalling is performed only during the hours specified by the user's Outcalling Schedule. Outcalling will be done only for messages received during the Outcalling period.

<b>Possible Cause</b>	<b>Corrective Action</b>
Outcalling may not be turned On.	Have the mailbox owner verify that Outcalling is turned on. The System Manager should also verify that the Outcalling privilege is assigned.
The number may be on the Disallowed Phone Numbers List or may not be on the Allowed Phone Numbers List assigned to the Outcalling port(s).	Check Outgoing Call Restrictions, Allowed and Disallowed Phone Numbers Lists, and list assignments.

**PROBLEM:** System does not respond to entered digits.

<b>Possible Cause</b>	<b>Corrective Action</b>
System is not receiving Touch-Tones.	PARTNER Messaging may not be able to interpret Touch-Tones while a prompt or recording plays. Wait until the prompt or recording finishes before entering the Touch-Tones.
The line is too noisy.	Have your incoming phone lines checked for noise and have any problems corrected.
The speakerphone's microphone is on, resulting in excessive background noise.	Mute the microphone or use the handset.
The Touch-Tone signals are not being transmitted to PARTNER Messaging.	This can occur when calling from a cellular phone because of the variable quality of signal transmission.

---

**PROBLEM:** Unanswered transferred calls ring continuously.

---

**Possible Cause**

In some areas, the telephone company does not provide a far-end disconnect signal. This causes the line to remain open even after the caller hangs up.

---

**Corrective Action**

Assign VMS Coverage to all extensions in the system; this is especially important for extension 10. Also, make sure VMS Coverage is on at extension 10 at night when no one is around to manually disconnect calls. When a call is sent to a voice mailbox for Call Answer Service, if PARTNER Messaging detects 15 consecutive seconds of silence, it will disconnect the call.

---

**PROBLEM:** Call Answer Service takes too long to answer calls.

---

**Possible Cause**

The communications system setting for the number of times a call rings before being sent to PARTNER Messaging for VMS Coverage may be too long. For PARTNER Advanced Communication Systems Release 3.0 or later, the factory setting for VMS Coverage is 3 rings; it is set on a per extension basis. For all other PARTNER communication systems the factory setting for VMS Coverage is 3 rings; it is set once for all extensions.

---

**Corrective Action**

Use the appropriate communications system programming procedure to decrease the number of rings before a call is sent for VMS Coverage.

Recommend that users program a Do Not Disturb button on their system phones. They should turn on the feature when they leave their desks or whenever they are too busy to answer calls. Calls to extensions with Do Not Disturb on are sent immediately to Call Answer Service.

---

All ports are busy.

If you have a 2-port or 4-port system, increase the number of ports. (PARTNER Messaging supports a maximum of six ports.)

---

**PROBLEM:** Call Answer Service terminates message while caller is recording.

---

**Possible Cause**

---

**Corrective Action**

The caller's recording time exceeded the mailbox's message time limit as specified in the mailbox Maximum Message Length setting.

Increase the Maximum Message Length setting for the mailbox. The setting can be from 2-60 minutes (the factory setting is 4 minutes).

---

The message capacity of the mailbox has been reached.

If the user requires more message storage capacity, increase the amount of time specified in the Mailbox Size setting.

The Mailbox Size can be set from 5-180 minutes. The factory setting is 20 minutes.

---

The message storage capacity of PARTNER Messaging (100 hours) has been reached.

Instruct users to delete unneeded messages.

---

The system has detected 15 seconds of silence.

None. This is normal operation.

---

**PROBLEM:** Message cannot be deposited in mailbox.

<b>Possible Cause</b>	<b>Corrective Action</b>
The mailbox is full.	When a user's mailbox is full, the caller cannot leave a message in that mailbox but is given the option of transferring to another extension. For all users, mailboxes can store up to 180 minutes of recorded messages (or 120 messages, whichever is reached first).  The factory-set Mailbox Size is 20 minutes. Instruct the user to delete unneeded messages. Increase the Mailbox Size, if necessary.
The system is full. The system can store a maximum of 100 hours of voice mail messages.	Instruct users to delete unneeded messages.
An Outcalling number is incorrectly programmed, forwarding Outcalling notification to an internal telephone associated with this mailbox. Each time a new message is received while Outcalling is in effect, the system will send the notification to this mailbox according to the specified number of Outcalling Cycles.	Verify that Outcalling numbers are correctly entered.

---

**PROBLEM:** User is unable to log in to Voice Mail Service.**Possible Cause****Corrective Action**

---

The user entered the mailbox extension incorrectly.

Make sure the user enters the mailbox extension number followed by (#).

- If the user tries again and succeeds, the problem is solved.
- If the user still cannot log in, see the next Possible Cause.

---

The user forgot his or her password or entered it incorrectly.

The user should try entering the password followed by (#) again.

- If the user can log in, the problem is solved.
- If the user still cannot log in, re-initialize the Mailbox Password. (If you forget the password for System Administration, you must call 1 800 628-2888 for help.)



---

**PROBLEM:** Date or time in message headers is incorrect.

<b>Possible Cause</b>	<b>Corrective Action</b>
The day, date, or time programmed for the communications system is incorrect or PARTNER Messaging was not updated with the correct time.	Refer to System Date (#101), System Day (#102), or System Time (#103) in the <i>Programming and Use</i> guide for the communications system to check the day, date, or time settings. If the day, date, and time are correct, choose one of these procedures and re-enter the correct value. After one minute, this updates the day, date, and time on PARTNER Messaging. If message headers for new messages (i.e., messages that are received after the day, date, or time has been reset) are still incorrect, call 1 800 628-2888 for help.

---

**PROBLEM:** User cannot forward messages to another user.

<b>Possible Cause</b>	<b>Corrective Action</b>
The system is full or does not have enough space remaining to accommodate the message.	The sender cannot forward the message until messages are deleted, freeing up message storage space.
The message has been forwarded the maximum of 13 times.	Verify the number of times the message has been forwarded.

---

**PROBLEM:** The PARTNER Messaging system is not answering calls.

---

**Possible Cause**

All PARTNER Messaging ports are in use. (This is normal operation when all ports are in use.)

---

**Corrective Action**

If you have a 2-port or 4-port system, you can upgrade the system with more ports by replacing the Port Card with a 4-port or 6-port card, as appropriate.

If the systems' users are using the Record-a-Call feature, each call being recorded uses one PARTNER Messaging port while the message is being recorded or listened to. If your system has four ports, you may want to upgrade the system to six ports.

---

<b>Possible Cause</b>	<b>Corrective Action</b>
The Port Card is not installed, is not installed correctly, or is defective.	<ul style="list-style-type: none"><li data-bbox="675 201 958 256">• If the Port Card is not installed, install it.</li><li data-bbox="675 280 1059 496">• Check that the Port Card is installed in Card Slot 1, the left-most PCMCIA card slot in the PARTNER Messaging module. If the Port Card is in the incorrect slot, remove it, and install it in the correct slot.</li><li data-bbox="675 520 1042 767">• If a Port Card is installed in Card Slot 1, the left-most PCMCIA card slot, remove it from the PARTNER Messaging module and reinstall it in Card Slot 1, making sure it is connected securely.</li><li data-bbox="675 791 1059 919">• If the Port Card is defective, it must be replaced. Call your authorized dealer or call the helpline at 1 800 628-2888.</li></ul>

---

**Possible Cause****Corrective Action**

The PARTNER Messaging module is not seated correctly in the communications system carrier, or the module is defective.

- If the System Status LED is not lit, power down the communications system, remove the PARTNER Messaging module and reseal the module in the communications system's carrier. Make sure the Port Card is securely connected in Card Slot 1, then power on the communications system. If the System Status LED does not light then the module may be defective. Call the helpline at 1 800 628-2888, or your authorized dealer, for help.
- If the System Status LED is red (other than for the instant in which the system is starting up), power down the communications system, remove the PARTNER Messaging module and reseal the module in the communications system's carrier. Make sure the Port Card is securely connected in Card Slot 1, then power on the communications system.
- If the System Status LED stays red for more than just an instant, then the module may be defective. Contact your authorized dealer or call the helpline at 1 800 628-2888.

Possible Cause	Corrective Action
None of the PARTNER Messaging extensions have been assigned to Hunt Group 7.	<p data-bbox="675 201 1053 355">Verify in the communications system programming that all the PARTNER Messaging port extensions are assigned to Hunt Group 7.</p> <ul data-bbox="675 379 1053 935" style="list-style-type: none"> <li data-bbox="675 379 1053 754">• Refer to the appropriate planning form for your communications system to determine the correct extension numbers for the PARTNER Messaging ports. Then, on the communications system, use Hunt Group Extensions (#505) programming to assign the port extensions to Hunt Group 7.</li> <li data-bbox="675 778 1053 935">• If none of these corrective actions solve the problem, call the helpline at 1 800 628-2888, or your authorized dealer, for help.</li> </ul>

**PROBLEM:** The caller cannot switch between Primary and Secondary Languages.

Possible Cause	Corrective Action
The system is set for Monolingual Mode.	<p data-bbox="675 1157 1053 1375">Refer to <a href="#">“Programming the System Language Mode and System Language”</a> on page 37 to determine the system’s Language Mode and change the mode to Bilingual, if not already set for that mode.</p>

---

**PROBLEM:** Cannot understand language prompts.

---

**Possible Cause**

Either a language you do not understand was inadvertently chosen while programming, or you do not understand the factory-set language. Note that the language for the programming prompts can differ from the System (or Primary) Language.

**Corrective Action**

Change the language to one you understand.

- See [“Selecting the System Administration Prompt Language” on page 36](#) to determine if the System Administration Prompt Language needs to be changed.
- See [“Setting the System Language” on page 38](#) if the system is set for Monolingual Mode and the System Language needs to be changed.
- See [“Setting the System Language” on page 38](#) if the system is set for Bilingual Mode and the Primary Language needs to be changed.

---

**PROBLEM:** Outside callers who should receive Automated Attendant Service hear ringing, but the system does not answer.

---

**Possible Cause**

All PARTNER Messaging ports are in use. (This is normal operation when all ports are in use.)

---

**Corrective Action**

If you have a 2-port or 4-port system, you can upgrade the system with more ports by replacing the Port Card with a 4-port or 6-port card, as appropriate.

If the systems' users are using the Record-a-Call feature, each call being recorded uses one PARTNER Messaging port while the message is being recorded or listened to. If your system has four ports, you may want to, upgrade the system to six ports.

**Possible Cause****Corrective Action**

The Port Card is not installed, is not installed correctly, or is defective.

- If the Port Card is not installed, install it.
- Check that the Port Card is installed in Card Slot 1, the left-most PCMCIA card slot in the PARTNER Messaging module. If the Port Card is in the incorrect slot, remove it, and install it in the correct slot.
- If a Port Card is installed in Card Slot 1, the left-most PCMCIA card slot, remove it from the PARTNER Messaging module and reinstall it in Card Slot 1, making sure it is connected securely.
- If the Port Card is defective, it must be replaced. Contact your authorized dealer or call the helpline at 1 800 628-2888.



---

<b>Possible Cause</b>	<b>Corrective Action</b>
The PARTNER Messaging module is not seated correctly in the communications system carrier, or the module is defective.	<ul style="list-style-type: none"><li data-bbox="675 201 1057 740">• If the System Status LED is not lit, power down the communications system, remove the PARTNER Messaging module and reseal the module in the communications system's carrier. Make sure the Port Card is securely connected in Card Slot 1, then power on the communications system. If the System Status LED does not light, then the module may be defective. **All other PARTNER communications systems:** On the communications system, check that the VMS Hunt Delay (#506) has been set to Immediate.

**Possible Cause****Corrective Action**

All PARTNER Messaging ports are in use.
